The *National Bureau of Investigation (NBI)*, through its Bids and Awards Committee (BAC), invites Suppliers/Dealers/Manufacturers to apply for eligibility and to bid for the hereunder project:

**Approved Budget of the Contract : Nine Million Five Hundred Thousand Pesos (P 9, 500,000.00)**

Prospective bidders should have experience in undertaking a single similar project within the last two (2) years, with a contract amount of at least 50% of the proposed project for bidding, from the date of submission and receipt of bids.

The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall also be conducted to determine responsiveness of the documents submitted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Revised Implementing Rules and Regulation (IRR).

Only those prospective bidders who purchased bidding documents will be allowed to attend the pre-bid conference.

Deadline of submission of bids is on December 13, 2011 at 8:30 am, Logistics office, Room 307, 3<sup>rd</sup> floor, NBI main building.
